1. Interpretation

1.1 In these terms and conditions:

9.0 Charge

9.1 The Client charges in favor of the Company any land that it owns (or acquires after the date of this agreement) as security for any and all monies owed to the Company and hereby authorizes and consents to the Company registering a caveat over the land if the Client defaults in making payment of any amounts owing to the Company.
